# <u>OSIC</u>

Our President as a Director of OSIC attended the 197<sup>th</sup> & 199<sup>th</sup> Board of Directors meeting of OSIC and took part in the discussions.

In the 198<sup>th</sup> Board of Directors meeting OSSIA raised the issue for reduction of service charges of OSIC for MSME units as per IPR 2015 not exceeding 1% of the sale value from the concerned unit. The Board discussed the proposal of OSSIA of reduction of the service charge of OSIC not exceeding 1% of the sale value as per IPR 2015 and were of the unanimous view that the matter needs to be discussed at the higher level, MSME Secretary / Chief Secretary for final outcome and authorized Managing Director and the representatives of OSSIA to discuss accordingly.

In the 199<sup>th</sup> Board of Directors meeting the Managing Director informed the Board that the Corporation has received letter No. PSUB-23/2019/4481/MSME dtd. 30.07.2019 from MSME Department, Govt. of Odisha confirming the levying of Service Charge not exceeding 1% on the products of the Micro and Small Enterprises in the line with IPR-2005 and the Board took note of the same.

OSSIA wrote a letter to CGM, OSIC Ltd with a copy to Chief Secretary, Director of Industries and Director, EP&M to reconsider the case of M/s Orissa Steel & Wire Products Pvt. Ltd. whose tender towards procurement of electrical materials against supply of order of CESU under FANI Cyclone restoration work has been rejected on the ground of non-payment of EMD which violates the clause 5.3.7 of the Odisha MSMED Policy 2016.

OSSIA wrote a letter to OSIC to release the payments of MSEs which is blocked for many days against which the sum has already been credited to the OSIC Account and requested for a vibrant payment system and curtailment of procedural delays and hassles.

OSSIA also wrote a letter to Managing Director, OSIC Ltd against the advertisement released in the daily News Papers inviting willingness from MSMEs, Agencies, Entrepreneurs, OSIC Empanelled Units, Traders and Logistic Entrepreneurs, Business Houses, Fabrication, Paints & Chemicals and Gem & Jewellery businessmen etc for new or expansion of existing business through OSIC. Which violates the provisions of IPR 2015 and defeated the purpose for which OSIC was formed.

OSSIA also wrote a letter to Managing Director, OSIC Ltd., to cancel the open tender floated by OSIC for procurement of (a) Bi-cycle Wheel Weeder (b) Bullock drawn cotton bond ridger (Light), (c) Bullock drawn cotton bond ridger (Heavy), (d) Bullock drawn cotton bond ridger with beams because there is no need for floating tender for these items. There is exclusive manufacturer of Bi-Cycle Wheel Weeder and few selective approved manufacturers for other three items and the rates for these items were also approved by the SLTC.



#### <u>MSMEDI</u>
