## OPERATIONAL GUIDELINES FOR EXEMPTION AND REIMBURSEMENT OF PREMIUM LEVIABLE ON CONVERSION OF LAND FOR INDUSTRIAL USE

(Reference: Para 7.2 of Odisha MSME Development Policy, 2022) (Effective from 30.11.2022)

- 1. Policy Provisions: Para 7.2 of Odisha MSMED Policy' 2022 states as follows. "New enterprises and existing enterprises taking up Expansion/Modernization/ Diversification will be granted exemption under the provisions of Section-73(C) and clause-C of Section 8(A) of Orissa Land Reforms (OLR) Act, 1960 from payment of premium leviable on conversion of land for industrial purpose in the following manner:
  - Enterprises with investment in Plant & Machinery up to INR 10 crores: 100% up to 5 acres
  - Enterprises with investment in Plant & Machinery more than INR 10 crores and up to INR 50 crores: @75% up to 25 acres"
- **2. Terms and Expressions:** Terms and expressions used in this operational guideline, but not specifically defined here, shall have the same meaning as in Odisha MSME Development Policy, 2022 (OMSMEDP-2022).

#### 3. Eligibility:

- **3.1** New industrial units / Existing industrial units taking up Expansion/Modernisation/Diversification, with an investment in Plant and machinery upto INR 50 crore, except units/activities listed under Annexure-II of Odisha MSMED Policy' 2022.
- **3.2** Migrated industrial unit/Rehabilitated sick industrial unit/ industrial unit seized under Section 29 of the State Financial Corporation Act, 1951/SARFAESI Act, 2002/ by the orders of NCLT under the IBC and thereafter sold to a new entrepreneur on sale of assets basis and treated as new industrial unit under Odisha MSMED Policy-2022.
- **3.3** Eligible Industrial unit that has availed this incentive under any scheme of State Government or Government of India or Government Agencies or any Financial Institution(s) shall be entitled only for the **differential** amount of benefit.
- 4. Procedure for exemption from payment of premium leviable on conversion of land for industrial purpose:
  - **4.1 Online Application:** Eligible Industrial units shall submit e-application and undertaking in the prescribed form appended to this operational guideline at Annexure-'A' along with self-attested copies of all relevant documents as mentioned in the Checklist at Annexure-'B' in the AIM Portal (www.aimdashboard.odisha.gov.in).

**4.2 Examination of application:** The General Manager (DIC) concerned shall examine the eligibility and if eligible, shall sign the Certificate of verification in the application form at Annexure-'A'.

#### 4.3 Recommendation:

- **4.3.1** For investment in P&M upto 10 crores, the General Manager (DIC) concerned shall recommend the case to the local Tahasildar in the format as per Annexure –'C' within next **3 working days** under intimation to the industrial unit.
- **4.3.2** For investment in P&M above INR 10 crore and up to INR 50 crore, the General Manager (DIC) concerned shall transmit the application to the Director of Industries, Odisha within 7 working days of receiving the application under intimation to the applicant. Director of Industries, Odisha shall examine the case and if found eligible, he/she will recommend the case to the local Tahasildar concerned within 15 working days in the format as per Annexure —'C' under intimation to the industrial unit and the General Manager (DIC) concerned.
- **4.4** On receipt of the recommendation from General Manager (DIC) or Director of Industries, Odisha, as the case may be, the local Tahasildar concerned shall examine the case and if found alright, shall allow exemption from payment of premium as due and admissible within next 7 working days. The amount of exemption (in INR) allowed shall be intimated by him/her to the General Manager(DIC) concerned or the Director of Industries, as the case may be.

### 5. Procedure for reimbursement of premium levied on conversion of land for industrial purpose:-

- **5.1 Online Application:**Industrial units those who have paid the premium leviable on conversion of land for industrial purpose after the effective date of this policy i.e **30.11.2022** shall submit e-application and undertaking in the prescribed form appended to this operational guideline at Annexure-'A1' along with self-attested copies of all relevant documents as mentioned in the Checklist at Annexure-'B1' in the AIM Portal (www.aimdashboard.odisha.gov.in) within six months from the date of commencement of production.
- **5.2 Examination of Application:** General Manager (DIC) shall first examine the eligibility of the unit for reimbursement of premium levied on conversion of land for industrial purpose. If found eligible, he/she shall cross-check from the Tahasildar concerned regarding the quantum of premium levied on conversion of land for industrial purpose. If found alright, he/she shall then sanction reimbursement of premium levied on conversion of land for industrial purpose, to the extent permissible, in favour of the applicant unit within **30 working days** of receipt of application and send the sanction letter to Director of Industries (Odisha) under intimation to the applicant.
- **5.3 Disbursement:** Director of Industries, Odisha shall, on receipt of the sanction letter of General Manager (DIC), satisfy himself/herself about correctness of the reimbursement claim and if found correct, shall disburse the amount within **15 working days** of receipt of the sanction letter to the eligible industrial unit directly.
- **6. Rejection:**-In case of **rejection** of application at any level, reasons of rejection must be communicated to the applicant unit and other stakeholders by the



authority concerned in the format prescribed at Annexure - 'D', within 15 days from taking such decision for rejection.

- 7. Recovery:-The amount of exemption allowed shall be recoverable with penal interest @ 18% per annum on following events.
  - A. If the information furnished is found to be false/ incorrect/misleading or misrepresented and there has been suppression of facts/materials.
  - B. If the industrial unit fails to commence production within three years from the date of first fixed capital investment.
  - C. If exemption is sanctioned erroneously or in excess of the actual amount due and admissible. However, if the industrial unit is found to be not responsible for such erroneous or excess payment, then no penal interest shall be charged on him/her.
  - D. If the industrial unit shifts the registered office of the unit outside the State without taking prior permission of the State Government.
